(b) If rent is unpaid when due, the landlord may deliver a

written notice to terminate the lease to the tenant

specifying the amount of rent and any late fees owed to

remedy the breach and that the rental agreement will

terminate upon a date not less than seven days after receipt

of the notice.

2013 Code of Alabama - Justia Law

If the breach is not remedied within the 14 days after

receipt of the notice to terminate the lease, the rental

agreement shall terminate on the date provided in the

notice to terminate the lease unless the tenant adequately

remedies the breach before the date specified in the notice, in which case the rental agreement shall not terminate.
