In cases of nonpayment of rent, the landlord must serve a written 5-Day Notice to the tenant to pay the required rent or vacate the unit. The notice must state the amount of rent owed, that the tenant can remain in the property if the entire rent is paid by a certain date, and that a Eviction Notice (Notice of Termination of Tenancy for ...

14 Day Notice for Substantial Breach (14 Day Eviction Notice) The landlord must give the tenant 14 clear days notice. This means that the landlord cannot count the day the notice is served on the tenant, and the landlord cannot count the day the tenant moves out.
