As part of their rights, a landlord can also increase the amount of rent charged to their tenant or tenants. However, you must follow state regulations, which are based on the size of the rent increase. For example, if you intend to increase the rent by 10% or less, you must provide at least 30 days notice to your tenants. If the planned increase exceeds 10%, you must notify your tenants 60
