Mobile home site rental covers refers to the rent of the land itself, as opposed to the rental of the home that it is located on. A mobile home site tenant is required to give two full months notice when ending a monthly periodic tenancy.

The tenant may also claim "all or any portion of any increased rent which the tenant has incurred or will incur for a one year period after the tenant has left the rental unit". The tenant must establish that they have rented another unit, and what the rent for that unit is. Tenant Notice to End Tenancy - Province of British Columbia

Multiple tenants: If any one of the tenants on a tenancy agreement serves the landlord notice to end the tenancy, the tenancy ends for all of the tenants in the rental unit on the effective date of the notice. A written agreement with the landlord is required for any tenants who want to continue renting the unit.
